Notification

The 25th September, 2024

No. 02/12/2024-1HFA.—The Governor of Haryana is pleased to notify a "Mukhya Mantri Gramin Awas Yojana". The policy, of which the details are given in Annexure-A below, is approved by the Council of Ministers in its meeting held on 12.07.2024. The policy has come into effect from the date of distribution of Adhikar Patra i.e. 30.7.2024.

Definitions

- "Beneficiaries under MGGBY" means those beneficiaries who were to be allotted plots under 1. Mahatma Gandhi Gramin Basti Yojana but who have not been given possession of the plots in the last fifteen years.
- "Government" means Government of Haryana for the State Government and Government of India for 2. the Central Government.
- 3. "Implementing Agency" means the agency responsible for executing tasks outlined by DHFA.

1. Policy Overview

PART I]

1.1. Background

Access to adequate shelter is as essential to human survival as food and clothing. A household needs a safe and secure place to live, which provides economic stability and social status. A house provides a physical and psychological base for households to meet basic needs such as food and clothing. For poor households, a house is an asset. They can offer this asset as collateral for a loan in a difficult time.

However, rural areas, where majority of population of developing countries live, face the problem of inadequate housing to higher intensity due to prevalence of incidence of poverty, inadequate availability of resources, poor saving, and obsolete technologies. With 824 million people, out of 1210 million living in rural India (68.8%), India's major housing problem has roots in the shortage of rural housing, both in quality and quantity. Housing shortage is known to have major implications in terms of quality of life and deprivation caused to the homeless in terms of benefits of economic development and employment.

Amidst the crisis of quality and adequacy of housing in the rural area, most vulnerable sections facing the brunt of the existing shortage are the marginalized sections of the society falling in the categories of SCs, BCs and other deprived castes who are at a clear disadvantage in terms of housing conditions and amenities when compared to other social categories.

Drawing inspiration from the vision of the Hon'ble Prime Minister i.e. Housing For All and understanding the magnitude, the challenge and importance of rural housing in Haryana, the Hon'ble Chief Minister as Finance Minister of Haryana, in his budget speech 2024-25, made the following announcement No.72: -

"On the lines of the Mukhya Mantri Shehri Awas Yojana, I propose to launch the Mukhya Mantri Gramin Awas Yojana to ensure that those beneficiaries who were to be allotted plots under Mahatma Gandhi Gramin Basti Yojana but who have not been given possession of the plots in the last fifteen years. I propose to set a deadline of September 2024 for giving possession to around 25,000 such beneficiaries. In case the possession cannot be granted to the eligible beneficiaries, then the Government will provide a benefit of up to ₹ 1 lakh to the beneficiary family under the Mukhya Mantri Gramin Awas Yojana so that they can buy a plot in the village at a location of their choice for construction of their residence."

1.2. Vision

To ensure that all the rural residents of Haryana have access to a habitable and affordable dwelling unit.

1.3. Mission

"Empowering Haryana through 'Mukhya Mantri Gramin Awas Yojna (MMGAY), aims to provide affordable, quality rural housing, fostering sustainable development and vibrant communities. Through strategic planning and transparent governance, MMGAY aims to make home ownership a reality for every rural resident, enhancing overall well-being and prosperity."

1.4. Objective

The government of Haryana aims to provide financial assistance of maximum of **Rs. 1,00,000** or actual price of the plot whichever is less, for purchase of his own residential plot of upto 100 sq. yards to those beneficiaries whom possession of plot cannot be delivered under Mahatma Gandhi Gramin Basti Yojana.

2. Scope and Duration

- 2.1. Mukhya Mantri Gramin Awas Yojana (MMGAY) will be implemented the year 2024-25 & 2025-26.
- 2.2. The Rural Development Department will provide the list of beneficiaries under Mahatma Gandhi Gramin Basti Yojana to whom possession of 100 sq. yards plot cannot be delivered.

3. Coverage Area

The scheme will cover those beneficiaries who were to be allotted plots under Mahatma Gandhi Gramin Basti Yojana but who have not been given possession of the plots in the last fifteen years.

4. Eligibility Criteria

List of beneficiaries provided by Rural Development Department under MGGBY who didn't receive possession of plots in last 15 years, are eligible.

5. Institutional mechanism




Figure 1 Organisation Structure

6. Procedure for implementation of Mukhya Mantri Gramin Awas Yojana (MMGAY)

- 6.1.1. Beneficiaries under MGGBY will be identified by the Department of Rural Development, Government of Haryana, as per scheme guidelines and any amendments thereafter. List of beneficiaries will be provided by the Rural Development Department.
- 6.1.2. On the basis of this list an "Adhikaar Patra" (Annexure-A) will be issued by the Department of Housing For All, Haryana to the beneficiaries which will be valid for one year from the date of issuance. The "Adhikaar Patra" will be distinguished by a QR code/unique code.
- 6.1.3. Data of beneficiaries along with detail of the "Adhikaar Patra" will be shared with the Revenue Department via API by HFA to Web HALRIS Platform.
- 6.1.4. The Revenue Department, Haryana will draft a "Standard Paragraph" (Annexure-B) that includes the buyer, seller and the "Adhikaar Patra" details and which shall become the part of sale deed. This "Standard Paragraph" would help avoid ambiguities while dealing with the beneficiaries of MMGAY at the time of registration of plot.
- 6.1.5. The beneficiary will have to buy a residential plot within a year of the issuance of the "Adhikaar Patra".

- 6.1.6. The registering authority for the purpose of Mukhya Mantri Gramin Awas Yojana (MMGAY) will be the concerned Sub Divisional Officer (Civil) (SDO (C)).
- 6.1.7. At the time of registration of plot, the buyer and the seller will present themselves before the registering authority with the following documents:
 - i. "Adhikaar Patra" issued by the Department of Housing For All, Haryana.
 - ii. Sale deed as per the Standard format (available on the Housing For All website link <u>https://hfa.haryana.gov.in/</u>).
 - iii. Photocopy of the Bank Passbook of the seller.
- 6.1.8 The registering authority will process the registration through Web HALRIS.
- 6.1.9 An API will be generated from the web HALRIS that will be accessed by the online portal of Department of Housing For All through which the registration details of the beneficiaries will be shared.
- 6.1.10 After registration of deed, data regarding deed e.g. details of buyers, sellers, property description, transaction amount etc will be shared to HFA for payment via an API on Web HALRIS.
- 6.1.11 The Department of Housing For All will maintain a Bank Account.
- 6.1.12 The information regarding sale, transfer of money gets intimated by way of SMS/email to the buyer, seller and the registering authority.






